Get the Flu Shot, not the Flu!

Protect yourself against the seasonal flu this year with a safe, effective vaccination.



You are a high-priority for the seasonal flu shot if:

- you have a chronic health condition, like diabetes, asthma, or diseases of the heart, kidney, liver, blood, or immune systems (review with your doctor); or
- you are a resident of a nursing home or long-term care facility; or
- you work in health-care in direct contact with patients ; or
- you live with or care for children less than 5 years of age, or adults 50 years or older, or persons with chronic health conditions (mentioned above); or
- you will be pregnant during the flu season (winter).

If you receive your benefit via direct deposit, the funds will be transferred on the dates above. If you receive a paper check, the check will be mailed on the business day prior to the date above.

If you move, please sign and return an Address Change Form to SamCERA by the 15th of the month in order for your information to be updated for that month's paycheck. Likewise, if you'd like to switch from a paper check to direct deposit, you must fill out and sign a Direct Deposit Form. All forms are available on the SamCERA website.

Investment Earnings

SamCERA's portfolio returned a healthy 13.6% for fiscal year 2012-2013. That number is what SamCERA earned after paying any required investment management fees.

The fund benefitted from the rally in global equity markets to beat SamCERA's policy benchmark return of 12.8%. Comparing SamCERA's portfolio return relative to the policy benchmark is one way of measuring the fund's performance, and it helps SamCERA measure the success of its active investment decisions.

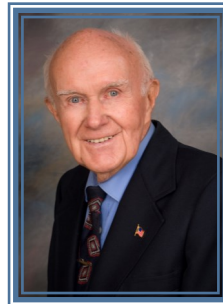
Retirement Board Elections and Appointments
