
## **Important Information for Retirees in 2019**

Changes to taxes and health plan premiums in 2019 could mean that you saw a change in your monthly pension benefit at the beginning of the year. Below are a few reminders:

- Tax Tables & Withholding: The Internal Revenue Service and the Franchise Tax Board revise their tax tables annually, which may change your monthly pension benefit from SamCERA. A licensed tax advisor can provide more information about these changes and your tax withholding options for 2019.
- Health Premium: If you pay for all or a portion of your health plan premium via your SamCERA pension benefit, changes to the health plan premium rates in 2019 may change the monthly benefit that you receive from SamCERA. For more information about the new 2019 retiree health benefit rates, contact the San Mateo County Benefits Division at (650) 363-1919.

### COLA FOR 2019

Effective April 1, 2019, retirees and beneficiaries will receive a cost-of-living adjustment (COLA) in an amount based on the member's plan.

SamCERA's COLAs are calculated according to state law and are based on the change in the annual Consumer Price Index for the San Francisco-Oakland-San Jose area as determined by the Federal Bureau of Labor Statistics. The law also requires the amount to be rounded to the nearest one-half of 1%.

This year, the Bay Area CPI (as validated by SamCERA's actuarial firm, Milliman, Inc.) showed a 3.87% increase, which was rounded to 4%. All COLAs will be paid beginning with the April 2019 benefit payments.

TO ELECT THREE MEMBERS TO THE BOARD OF RETIREMENT

Notice is hereby given that one GENERAL MEMBER is to be elected to fill the third position, and one RETIRED MEMBER is to be elected to fill the eighth position on SamCERA's Board of Retirement. An alternate Retired member will also be elected.

General Member Eligibility: Candidates must be active SamCERA General members. Each candidate for the General member position shall be nominated by a petition signed by not less than ten (10) active SamCERA General members.

Retired Member and Alternate Retired Member Eligibility: Candidates must be retired SamCERA members and may only nominate themselves to one position, either the Retired Member seat or the Alternate Retired Member seat.

Member Terms: The General member, the Retired member and the Retired member alternate shall serve from July 2019 – June 2022.
