On July 9, 2019 the San Mateo County Board of Supervisors presented SamCERA with a resolution in recognition of our 75th anniversary.

Meet the Board

On June 4, 2019, the Board of Supervisors reappointed Ben Bowler (Fifth Member) for a fourth term, and Kurt Hoefer (Ninth Member) for a second term, to the SamCERA Board of Retirement. Ben Bowler is the Treasurer for Matson, Inc., and Kurt Hoefer is a partner at investment advisor Golub Group, LLC. The new terms for both appointments began July 1, 2019 and will expire on June 30, 2022.

The nomination period for the 2019 Board of Retirement election closed on May 6, 2019 at 5:00 p.m. Each incumbent ran unopposed and was therefore certified elected by the San Mateo County Elections Officer. Al David was reelected to the General Member Third Seat, Paul Hackleman was reelected to the Retired Member Eighth Seat, and Alma Salas was reelected to the Alternate Retired Member Seat. The next election will be held in 2021.



Adjust Your Withholding at Any Time

As a retiree, you have the option to elect whether to have Federal or CA State tax withheld from your SamCERA benefit.

If at any time you wish to change your tax election, you may do so by completing a new Tax Withholding Certification form and returning it to SamCERA. You can also make changes online at MySamCERA.org.

Printed copies of your 1099-R form will be mailed by January 31, 2020, but did you know that you can print a copy of your 1099-R form from home? Beginning on February 1, 2020, you will be able to view and print your statement online by signing into your MySamCERA account. Select "My Documents" on the navigation menu, and from there you have the option to view or print a copy.
