## **2024** Cost-Of-Living Adjustment Increase

he Board of Retirement approved a cost-of-living adjustment (COLA) for most retirees and beneficiaries that will begin with the April 2024 retirement benefit payment.

The COLA applies to eligibile retirees and beneficiaries who retire on or before April 1, 2024, and the amount of the COLA may vary depending on the retirement plan. All COLAs will be paid beginning with the April 30, 2024 benefit payment.

Retiree or Beneficiary's Plan Type	Date of Retirement	2024 COLA %	COLA BANK %
Plan 1 - General and Safety	On or before 4/1/2024	4.0%	0.5% decrease
Plan 1 - Probation	On or before 4/1/2024	3.0%	0.5% increase
Plan 2 - All Members	On or before 4/1/2024	3.0%	n/a
Plan 3	n/a	n/a	n/a
Plan 4, 5, 6, 7 - All Members	On or before 4/1/2024	2.0%	n/a

The COLA for Plan 1 General and Safety members is 4.0%, which includes 3.5% based on the Consumer Price Index in addition to 0.5% from their COLA bank. These members will now have a zero COLA bank balance.

Plan 1 Probation members will receive a 3.0% COLA with a 0.5% COLA bank. The COLA for Plan 2 members is 3.0%, and the COLA for Plans 4, 5, 6 and 7 is 2.0%. Plan 3 does not provide a COLA.

#### TO ELECT THREE MEMBERS TO THE BOARD OF RETIREMENT

Notice is hereby given that one **GENERAL MEMBER** is to be elected to fill the second position, and one SAFETY MEMBER is to be elected to fill the seventh position on SamCERA's Board of Retirement. An ALTERNATE SAFETY MEMBER will also be elected.

**General Member Eligibility:** Candidates must be active SamCERA General members.

Safety Member Eligibility: Candidates must be active Safety or Probation Safety members.

Alternate Safety Member Eligibility: For the purposes of this election, Safety membership is divided into two groups, Probation and Safety. The candidate for the Safety member seat who receives the highest total number of votes will be elected to the Safety member seat. The candidate who is a different group from the candidate elected to the Safety member seat and who receives the highest number of votes of any candidate of that group will be elected as Alternate Safety member.

Member Terms: The General member, the Safety member and the Alternate Safety member shall serve from July 1, 2024 – June 30, 2027.

**Declaration of Candidacy:** This form will be available and can be circulated beginning **Monday**, April 15, 2024 through Monday, May 6, 2024. Qualified Candidates may obtain petition forms in person at:


Completed Declaration of Candidacy: This completed form must be filed in person with the Registration & Elections Division no later than 5:00 p.m. on May 6, 2024.

## Your 2023 Tax Forms Are Now Available On MySamCERA

1099-R Annual Tax Reporting Statements were mailed in January and are available online now.

The IRS 1099-R Form contains information about reportable income and taxable income from SamCERA for the previous calendar year. It will also reflect the amount of federal and California taxes that have been withheld.

#### Access Your 1099-R Online

Your 1099-R is available to view and print in the MySamCERA member portal. Follow the simple steps below to access your form:

- Log in to MySamCERA
- Click on Your Plan in the navigation menu
- Click on 1099R Tax Information
- Select the 1099R form (current or past) that you would like to view

Once logged in, click on the **Your Plan**, and then click on **Upload/View Documents** to view and print your statements.

## **Update Your Tax Withholding Anytime**

You can change your tax withholding election anytime throughout the year by completing a new Tax Withholding form (available at www.samcera.org/forms). Requests to increase or decrease your withholding that are received by the 15th of the month are effective in that same month. Requests received after the 15th become effective the following month.
